

# Home Contents Insurance





A special service for tenants and leaseholders of Victory Homes

Many customers believe that Flagship Homes automatically insure their furniture, belongings and decorations against fire, theft, vandalism or water damage such as burst pipes. THIS IS NOT THE CASE. You need to take out your own household insurance either with this special scheme through Aviva or by making your own arrangements.

\* This scheme is open to all Flagship Homes residents. This is one of many options available to residents in the insurance market place. Flagship Homes cannot guarantee that this scheme provides the cheapest insurance cover available, or that it provides the widest cover – you are recommended to seek alternative quotations and choose the cover which best suits your needs.



# Insurance for your home contents (see insurance product information document)

When you take out this insurance your household goods and contents will be insured whilst in your home against events such as fire, theft and flooding. The insurance also covers theft of your keys and the contents in your freezer. There is also cover for personal liability.

Accidental damage and cover away from your home are not covered as standard other than as detailed in the enclosed insurance product information document. However, a full accidental damage option is available at an additional cost (see cost of insurance table and insurance product information document ).

There are also optional extras available for you to choose from including personal belongings, wheelchair and hearing aid cover for an additional premium. This gives much wider cover for the optional extras. It protects your belongings if they are stolen or accidentally damaged or if you simply lose them. Cover is worldwide so protects items you take away from the home as well as giving extra cover in your home or garden (please refer to the Cost of Insurance table attached) Please refer to the enclosed insurance product information document which details the main circumstances that are covered (e.g. fire, theft, water damage). There is no cover for wear and tear or mechanical breakdown. A specimen policy booklet is available on request.



### Special low, minimum sums insured

The lowest amount that can be insured is: £6,000 if you are over the age of 60. £9,000 for all other people



### "New-for-Old" insurance

All your home contents are covered by the policy on a 'new for old' basis, with the exception of linen and clothing which will be replaced at their current cost, less an amount for wear and tear. When you are working out the cost of your insurance, you will need to work out how much it will cost to replace the full contents. If you under value your contents this will mean that if you claim you may not get the full value of your claim.

### **Option 2 - By Telephone**

Cover can be arranged by telephone by calling the Wessex Administration quote line on telephone number 01962 892 086. If you choose this method, please ensure you read the insurance product information document and the important information contained in this pack and query anything you do not understand before proceeding with this insurance.



### Payment of the premium

You will need to decide how you would like to pay the premium. The options available are:

- Fortnightly by cash using a swipe card at any post office or Payzone outlet
- · Monthly by direct debit
- Annually by cheque, postal order or debit/credit card.



### Keeping up the payments

- To make sure that you are always covered you must keep up to date with your payments.
- Wessex Administration can cancel the policy if your premium payments fall into arrears.
- You may not be able to make a claim unless your payments are up to date.



### Start date

Insurance starts when Wessex Administration informs you that you have been accepted onto the scheme. Wessex Administration will write to you with details of your insurance payments and the date when you should start paying. You will be notified in writing if for any reason, you have not been accepted into the scheme.

### **Special Notes**

- If during the period of your insurance cover your home is likely to be unoccupied (e.g. if you are in hospital, extended holiday) for more than 60 consecutive days you will have to advise Wessex Administration.
- Remember, it is your responsibility to ensure that the sum insured is sufficient to cover all your household items and personal effects.

Flagship Homes urges all tenants to take out household insurance, either through our special scheme or by making your own arrangements.

### **DATA PROTECTION - PRIVACY NOTICE**

### **Personal Information**

We collect and use personal information about you so that we can provide you with a policy that suits your insurance needs. This notice explains the most important aspects of how we use your information but you can get more information about the terms we use and view our full privacy policy at www.aviva.co.uk/privacypolicy or request a copy by writing to us at Aviva, Freepost, Mailing Exclusion Team, Unit 5, Wanlip Road Ind Est, Syston, Leicester LE7 IPD.

The data controller responsible for this personal information is Aviva Insurance Limited as the insurer of the product. Additional controllers include the Administrator, Flagship Housing Group Limited and Aon UK limited who are responsible for the sale and distribution of the product, and any applicable insurers, reinsurers or brokers we use.

### Personal information we collect and how we use it

We will use personal information collected from you and obtained from other sources:

- to provide you with insurance: we need this to decide if we can offer insurance to you and if so
  on what terms and also to administer your policy, handle any claims and manage any renewal,
- to support legitimate interests that we have as a business. We need this to:
- manage arrangements we have with our insurers, reinsurers and brokers we use, and for the detection and prevention of fraud
- help us better understand our customers and improve our customer engagement. This includes
  profiling and customer analytics which allows us to make certain predictions and assumptions
  about your interests, make correlations about our customers to improve our products and to
  suggest other products which may be relevant or of interest to customers,
- to meet any applicable legal or regulatory obligations: we need this to meet compliance requirements with our regulators (e.g. Financial Conduct Authority), to comply with law enforcement and to manage legal claims, and
- to carry out other activities that are in the public interest: for example we may need to use personal information to carry out anti-money laundering checks.

We may also use personal information about other people, for example family members you wish to insure on a policy. If you are providing information about another person we expect you to ensure that they know you are doing so. You might find it helpful to show them this privacy notice.

The personal information we collect and use will include name, address and date of birth, financial information and details of your home. If a claim is made we will also collect personal information about the claim from you and any relevant third parties. We may also need to ask for details relating to the health or any unspent offences or criminal convictions of you or somebody else covered under your policy. We recognise that information about health and offences or criminal convictions is particularly sensitive information. We'll ensure that we only use that information where we need to for our insurance purposes (including assessing the terms of your insurance contract, dealing with changes to your policy and/or dealing with claims).

There may be times when we need consent to use personal information for a specific reason. If this happens, we will make this clear to you at the time. If you give us consent to using personal information, you are free to withdraw this at any time by contacting us – refer to the "Contacting us" details below. Please note that if consent to use information is withdrawn we will not be able to continue to process the information you gave us for this/these purposes. This would not affect our use of the information where consent is not required.

Of course, you don't have to provide us with any personal information, but if you don't provide the information we need we may not be able to proceed with your application or any claim you make.

Some of the information we use as part of this application may be provided to us by a third party. This may include information already held about you and your home within the Aviva group, including details from previous quotes and claims, information we obtain from publicly available records, our trusted third parties and from industry databases, including fraud prevention agencies and databases.

### **Automated decision making**

We may carry out automated decision making to decide whether we can provide insurance to you and on what terms, deal with claims or carry out fraud checks. In particular we may use an automated underwriting engine to provide on-line quotes, using the information we have collected.

### How we share your personal information with others

We may share your personal information:

- with the Aviva group, our agents and third parties who provide services to us, the Administrator,
  Flagship Housing Group Limited and Aon UK limited, and other insurers (either directly or via
  those acting for the insurer such as loss adjusters or investigators) to help us administer our
  products and services,,
- with regulatory bodies and law enforcement bodies, including the police, e.g. if we are required to
  do so to comply with a relevant legal or regulatory obligation,
- with other organisations including insurers, public bodies and the police (either directly or using shared databases) for fraud prevention and detection purposes,
- with reinsurers who provide reinsurance services to Aviva and for each other in respect of risks underwritten by Aviva, with insurers who cover Aviva under its group insurance policies and with our brokers who arrange and manage such reinsurance and insurance arrangements. They will use your data to decide whether to provide reinsurance and insurance cover, arrange and manage such cover, assess and deal with insurance and reinsurance claims under such cover and to meet legal obligations. They will keep your data for the period necessary for these purposes and may need to disclose it to other companies within their group, their agents and third party service providers, law enforcement and regulatory bodies.

Some of the organisations we share information with may be located outside of the European Economic Area ("EEA"). We'll always take steps to ensure that any transfer of information outside of the EEA is carefully managed to protect your privacy rights. ### How long we keep your personal information for

We maintain a retention policy to ensure we only keep personal information for as long as we reasonably need it for the purposes explained in this notice. We need to keep information for the

period necessary to administer your insurance and deal with claims and queries on your policy. We may also need to keep information after our relationship with you has ended, for example to ensure we have an accurate record in the event of any complaints or challenges, carry out relevant fraud checks, or where we are required to do so for legal, regulatory or tax purposes.

### Your rights

You have various rights in relation to your personal information, including the right to request access to your personal information, correct any mistakes on our records, erase or restrict records where they are no longer required, object to use of personal information based on legitimate business interests, including profiling and marketing, ask not to be subject to automated decision making if the decision produces legal or other significant effects on you, and data portability. For more details in relation to your rights, including how to exercise them, please see our full privacy policy or contact us – refer to the "Contacting us" details below.

### Contacting us

### **Fraud Prevention and Detection**

In order to prevent and detect fraud we may at any time:

- · Share information about you with other organisations and public bodies including the Police;
- Undertake credit searches and additional fraud searches;
- Check and/or file your details with fraud prevention agencies and databases, and if you give us
  false or inaccurate information and we suspect fraud, we will record this to prevent fraud and
  money laundering.

We can supply on request further details of the agencies and databases we access or contribute to and how this information may be used. If you require further details please contact us at:

- Trace debtors or beneficiaries, recover debt, prevent fraud and to manage your accounts or insurance policies;
- Check your identity to prevent money laundering, unless you provide us with other satisfactory proof of identity;
- Check details of job applicants and employees.

### **Claims History**

- Under the conditions of your policy you must tell us about any insurance related incidents (such
  as fire, water damage, theft or an accident) whether or not they give rise to a claim. When you
  tell us about an incident we will pass information relating to it to a database.
- We may search these databases when you apply for insurance, in the event of any incident or claim, or at time of renewal to validate your claims history or that of any other person or property likely to be involved in the policy or claim.

You should show these notices to anyone who has an interest in the insurance under the policy.

### IF YOU HAVE A COMPLAINT

We hope that you will be very happy with the service that we provide. However, if for any reason you are unhappy with it, we would like to hear from you. In the first instance, seek resolution by contacting Aviva Tenants Contents Unit on telephone number 0345 0308 733. Aviva is covered by the Financial Ombudsman Service. If you have complained to us and we have been unable to resolve your complaint, you may refer it to this independent body. Following the complaints procedure does not affect your right to take legal action.

### **CHOICE OF LAW**

The Law of England and Wales will apply to this contract unless:

- 1) You and the Insurer agree otherwise; or
- 2) At the date of the contract you are a resident of (or, in the case of a business, the registered office or principal place of business is situated in) Scotland, Northern Ireland, Channel Islands or the Isle of Man, in which case (in the absence of agreement to the contrary) the law of that country will apply.

### **TELEPHONE CALL CHARGES AND RECORDING**

Calls to 0800 numbers from UK landlines and mobiles are free. The cost of calls to 03 prefixed numbers are charged at national call rates (charges may vary dependent on your network provider) and are usually included in inclusive minute plans from landlines and mobiles. For our joint protection telephone calls may be recorded and/or monitored.

### What is this type of insurance?

Tenants home contents insurance protects you against loss or damage to your Contents. It covers such things as fire, flood, storm, theft, escape of water and subsidence – as described in our policy booklet.



### What is insured?

The amount we'll pay to replace your contents is specified by you.
